

Five 445th Airmen selected for promotion to colonel

Air Reserve Personnel Center officials announced Dec. 7, 2015 the results for the Calendar Year 2015 Air Force Reserve Line and Non Line Colonel Promotion Selection Boards. The boards selected more than 150 Citizen Airmen for promotion.

The selection boards convened at ARPC October 5-9 to determine those officers best qualified to assume the next higher grade. Board members selected 163 of 1,538 officers considered. Five reservists from the 445th Airlift Wing were selected.

Categories considered during these promotion boards were: Air Force Reserve Line, Dental Corps, Medical Corps, Nurse Corps, Medical Service Corps, Biomedical Sciences Corps, Chaplains and Line of the Air Force Judge Advocates.

Veteran shares emotional story of service

Members of the 445th Airlift Wing and 120 local veterans celebrated the holiday season with food and comradery at the Dayton Veterans Affairs Medical Center December 5, 2015.

Reservists served food in the lobby and delivered food to the rooms of veterans who were less mobile.

While visiting, I had the opportunity to meet a veteran and hear tales from another era.

William L. Jay, an Army private first class drafted in 1951, sat in his room watching television. The Korean War vet wore an orange, long-sleeve shirt with "Turkey Trot 2015" and had a blanket draped over his lap. He appeared content as he watched TV. Food and a soda were served to him in his room. He requested that each Airmen visiting him sign his log book.

As I visited Mr. Jay, I was curious to hear his stories, so I requested that he share memories of his time in service.

Jay told me tales about bayonet training from a scarred master sergeant; missing the assignment to Korea by one name; the endless tulip fields in Holland; and occupying a post war-torn Germany.

I asked him about his plans for the holidays.

"Well I hope I get to go home," he said.

I proceeded to ask him how the holidays were celebrated during his time of service.

He paused for a moment and then said, "We got better meals than what we normally did."

"When I was in basic, they set the lights off in the mess hall and passed around a helmet," said Jay. "They said 'take one piece of paper out of the helmet and pass it around.'"

Every 445th Airman is on the championship team

Welcome back from the holidays, to our service together in Air Force Reserve Command's finest airlift wing.

You have a lot to be proud of when you reflect on 2015, where we followed winning the Clouse Trophy in 2014 (best maintenance group in 4th Air Force) with the wing's selection for the 2015 Air Force Outstanding Unit Award.

Every 445th Airman gets to wear this on your uniform, and I encourage you to be proud of that achievement.

These recent achievements set us up to max-perform the challenges ahead in 2016, which include a formal unit effectiveness inspection in June when we host the



AFRC Inspector General team.

Planning is underway for the exercise scenarios that will test our rapid response to specific mission taskings across the wing during our March unit training assembly, and again for the June CAPSTONE event. Our compliance programs are already being evaluated by online inspectors, which is why each of us needs to embrace the cultural change toward mission effectiveness, not inspection readiness.

We're well on the way toward executing a culture of continuous process improvement, with every Airman on our championship-winning team encouraged to function as a sensor. What I mean by this is that you should realize you're empowered to identify areas where we can improve our performance: bring these to the attention of your leadership! You're expected to know your role on the team and to back each other up when your wingman misses a tackle. The term "every Airman a sensor" means we work together to prevent undetected non-compliance, and bring it into the light of day so the wing can work toward a solution.

Part of improving your sensor awareness is through training, and it's why I need you to complete a

short (under 30 minutes) online CBT that explains every Airman's role in the Air Force Inspection System. Trust me, I understand how piling on computer training lessons competes with the primary skills training that attracted you to your Air Force specialty, and this is a message that every wing commander relentlessly up-channels to big Air Force. But the particular CBT will clarify your role in self-evaluating and guaranteeing our readiness. It's worth the time invested.

Here's my direction before the March UTA: just log onto ADLS through the Air Force Portal, select the AFIS CBT (search for ZZ133134), listen to the general introduction and then select your specific role. You'll be complete in under 30 minutes. I would ask that commanders go the extra mile and review all of the roles – it adds valuable knowledge to our toolkits. But whatever your position and specialty within the wing, understanding your role in our self-inspection system is critical to our ability to maintain the readiness contract we've made with America....and it's what helps us continue to be "proud of the patch" that we wear for the 445th. See you at the UTA.

JAG Airman named Air Reserve Paralegal of the Year

Master Sgt. Rebeccah Stammen, 445th Airlift Wing Office of the Staff Judge Advocate superintendent, won the David Westbrook Award for Outstanding Air Reserve Component Paralegal of the Year for 2014.

The award recognizes the most outstanding Air Reserve Component paralegal of the year based on demonstrated superior initiative, technical skill, training accomplishments or contribution to mission support, exhibition of leadership in the military or civilian community and enrollment in off-duty programs of professional self-improvement.

Stammen completed a multi-year review of Uniform Code of Military Justice actions, compar-

ing data and developing unit commander reference for use in taking military justice actions. She researched the legality of allowing armed security forces personnel to use privately owned vehicles when responding to active shooter threats, offering additional options during times of crisis. Stammen coordinated legal issues across four divisions, managing more than 500 suspenses and identifying more than 60 critical compliance areas during a self-inspection. The sergeant led a high-visibility records review, compiling 24 sexual assault files and enabling the command to meet a short-notice suspense from a U.S. Senator.



Airmen must keep SGLI, emergency data current

Several years ago, an Airman at another base passed away and his current spouse was told that his former spouse would receive the entire \$400,000 insurance payment because the husband had failed to update his beneficiary form after his most recent marriage. As a legally binding contract, the form required the entire amount go to his named beneficiary.

This incident illustrates the critical need for Airmen to maintain both their Servicemembers' Group Life Insurance form and their virtual Record of Emergency Data.

The SGLI form, SGLV 8286, is the only document used to legally identify the beneficiary for an SGLI payment in the event of death. The vRED is used to contact next-of-kin in the event of serious injury or death. It is also used to identify the person who will make funeral and final resting place decisions for the deceased Airman, as well as designate the beneficiary for any unpaid allowances or final salary, explained Senior Airman Umar Yasin, 445th Force Support Squadron customer service technician.

"We encourage members to update their vRED any time they experience a major life event, like marriage, the birth of a child, a deployment, or a move," said Yasin.

However, the vRED does not delineate SGLI payment beneficiaries.

"Unlike testamentary documents like wills, insurance is a contract," said Maj. Omar Ebarb, 445th Deputy Staff Judge Advocate. "So even if you want your

insurance payments to go to your heirs, they won't unless you specifically name them in the documentation."

SGLI provides group term life insurance, with coverage up to \$400,000, or lesser amounts in increments of \$50,000. As Reservists, members of the 445th Airlift Wing are automatically enrolled with full coverage unless they fill out paperwork denying it or changing the coverage amount. SGLI coverage can help in case of injury, as well as death.

"Airmen can claim up to \$25,000 for traumatic injuries," explained Yasin, "and the \$400,000 coverage amount remains unchanged."

Reservists may not realize that insurance coverage also extends to family members.

"Children are automatically covered for \$10,000 under the Family Servicemembers' Group Life Insurance at no cost," said Yasin. "Spousal coverage is equal to the amount of the Airman's coverage, not to exceed \$100,000."

Members are also covered for 120 days following separation or release from duty, at which point they can apply for Veterans' Group Life Insurance through the Department of Veterans Affairs.

If you initially declined SGLI and wish to obtain or increase coverage, you can stop by the military personnel flight and complete and sign a form SGLV 8286. You can verify the beneficiaries on your SGLI by accessing the Personnel Records Display Application (PRDA) on the Air Force Portal.

"When you're in El Paso, heck you might as well be off the edge of the earth," said Jay. "We didn't have any through traffic."

Again, Jay stopped and appeared deep in thought.

This is where the holiday story almost ended. But I wanted

closure on the Christmas story.

I asked him if he got to see his family that Christmas.

"Yes," he replied. "It was just a long train ride home."

I thanked him for his service,

signed his log book and said goodbye.

I plan to spend the holidays with family as well. I'm grateful that I will not have to depend on the drawing of a red ticket (or someone else's for that matter) out of a helmet. Not all opportunities are paved with the path of convenience. Jay must have known that, and he acted accordingly.

William L. Jay saw his family in West Milton, Ohio the year of his basic training in 1951. He hopes to see them again this year. He spent his Thanksgiving dinner with his family last month.

Annual awards banquet

AFRC Top Three Scholarships

Air Force Reserve Command Total Force Top Three is offering 20 scholarships in the amount of \$500 each to further military and family members college education pursuits.

Completed packages must be submitted no later than January 15, 2016.

Eligibility

- Rank of E-9 or below or immediate family member of E-9 and below (i.e., daughter, son, etc.)
- Military member must be a current member of the Air Force Reserve, Air Force Reserve Command, or a family member of the above.
- Currently enrolled in an associates, bachelor, or master's degree program at a regionally accredited college or university during the upcoming semester or have "Letter of Acceptance" from Registrar's Office from a regionally accredited college or university. Students with an earned master's degree are not eligible to apply.
- Grade Point Average of 3.0 or above (within last 6 months).
- If new college student, must have last high school transcript.
- Must not have been a Total Force Top 3 Scholarship recipient in the last 12 months.

The Total Force Top 3 scholarship committee determines appropriate qualifications and the distribution of money, and will be the final determining body for awarded scholarships. Funds shall be applied to tuition, books, and/or academic fees at a regionally accredited college or university for the 2016-2017 academic years.


