

445th Honor Guard represents members past, present

When 445th Airlift Wing Airmen attend a military function, they may see the Colors being posted, observe a flag folding ceremony or hear taps being played during somber moments. The men and women behind the scenes performing these functions are members of the honor guard.

Airmen serving in the 445th AW Honor Guard play a significant role in the Wright-Patterson Air Force Base Honor Guard program. In 2018 alone, 445th Honor Guard members performed in approximately 502 of 3,478 military funerals, which equals 14.4 percent of the base's overall mission.

The honor guard's primary mission is to provide military funeral honors for active-duty members, retirees and veterans who served honorably in the Air Force within their six-state 210,000 square mile area of responsibility. States include all of Ohio, Michigan, Kentucky; half of Indiana and West Virginia, and two counties in Pennsylvania.

"Members of the 445th Honor Guard are expected to maintain the highest standards of professionalism, and depending on rank be a true mentor as an NCO or a peer mentor as an Airman," said Master Sgt. Shawn McKellop, 445th Force Support Squadron, superintendent, 445th Honor Guard, Guard and Reserve Liaison, Wright-Patt Honor Guard. "We tend to have irreplaceable experience and our members are volunteers and highly competitive."

McKellop, who's been a member of the 445th Honor Guard since 2007, said one of his biggest hurdles are scheduling and manpower or multiple events being held at the same time.

"The biggest challenge to the base honor guard is our scheduling once we've reached our full time per-

sonnel limit. We reach out to Guard and reserve bases to utilize their part-time members, usually on Fridays, Saturdays and Mondays," said McKellop.

Being a member of the honor guard requires dedication, determination and a strong sense of duty.

"Working within the honor guard career field is one of the most rewarding things I have ever done," said Tech. Sgt. Lisa Purk, 445th Aeromedical Staging Squadron mental health technician and current honor guard member. "It is a privilege to be a part of this mission and a visual representation of the sacrifice made by our comrades."

Purk said the honor guard represents every member, past and present. She feels that the honor guard is an integral part of the healing process for military families.

"We are standing in the gap between them (military families) and their loved ones. We are tangible, just like the flag that they hold in their hands. Being able to comfort these people in the short time that we interact is important. They might not remember our ranks, our names and our faces, but

they will always remember the day that we gathered to remember the sacrifices made in service to this country."

The 445th AW has a history of providing support. Some members serve six months and others serve several years.

"I have made it my life's work to honor our country's veterans," said McKellop.

All openings will be announced on USAjobs. Another source of information is the SEU (Special Examining Unit).

ART positions are announced through the SEU on USAJOBS as "case exams" and "standing registers." A case exam is a one-time announcement for a specific job at a specific location and is normally open for a five business day period.

Open continuous announcements (Standing Registers) are the exception to case exams. They are established when there is a consistent need to maintain a pool of qualified applicants to fill possible various vacancies/locations.

FM tip of the month — long, short orders certification

The 445th Reserve Pay Office January tip of the month is processing long and short orders.

Long and Short Orders

- Short orders are orders less than 30 days and members receive Basic Allowance for Housing Type II.
- Short orders (Military Personnel Appropriation in support of a Contingency) receive full BAH.
- Long orders that are exactly 30 days receive BAH Type II.
- Long orders that are more than 30 days receive full-rate BAH.
- Long orders must be more than 33 days for the member to earn leave.

Do's

1. Certify all short orders in AROWS
 - a. Exceptions are for members married to military members and orders with displaced travel days
 - a. Timekeeper signature needed for Air Reserve Technicians
 - b. Pre-certification is required to start orders
 - c. For Pre-certification fill out the "Statement of Tour of Duty" 36 a and b, and 37 - 44. If you are an ART, complete 45 - 47 on the Air Force Form 938.
 3. Long orders must be closed-out by completing the "Statement of Tour of Duty" 36 c and d, at the completion of the orders.
 4. Not closing out long orders can result in member not being issued a leave number for leave on future orders.

Don'ts

1. Expect payment as soon as your orders are turned in (pay is determined by scheduled pay-Dates and cannot be expedited.)
2. Leave blank spaces on your orders when certifying.
3. Forget to circle the correct responses on the AF Form 938, 37.

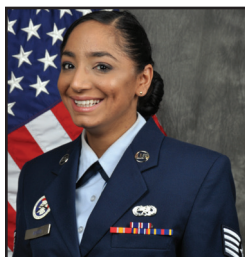
Wing announces 4th quarter CY18 award winners

Senior Airman Devin Copeland, 445th Aero-medical Evacuation Squadron AE technician, is the 445th Airlift Wing Airman of the Quarter. Copeland developed an in-flight equipment tracking system; accountability for more than \$400,000 with a 93 percent decrease in system failures. He created an orientation packet for newcomers and mentored new Airmen on the Air Force Reserve Command AES Radio Frequency Identification tracking system. Copeland assisted another base's AE unit during a training exercise with 1,200 Airmen using three aircraft. The Airman helped to showcase AE to an audience of more than 100,000 people at three air shows. Copeland performed volunteer work with the American Legion by delivering Christmas gifts and food to more than 100 homes. He organized a moral trip with more than 30 Airmen to deliver food and supplies to 50 families. Copeland participated in a Memorial Day event where he carried the American flag and laid a reef in front of more than 200 attendees.

NCO



Staff Sgt. Jowanda Ayoub, 445th Maintenance Group maintenance management production journeyman, is the 445th AW NCO of the Quarter. Ayoub was a key member of the Air Force Reserve Command manpower study where she evaluated man hour requirements and provided clarity that impacted 24 maintenance groups with 450 AFRC Airmen. She produced a maintenance information system app, increasing functional assessment productivity. The NCO built continuity folders and one-on-one training, reducing the office workload by 50 percent. Ayoub led a joint women's symposium attended by more the 1,000 members from 13 different countries. She dedicated 14 hours to the Veterans Home, assisting veterans and boosting their morale. The NCO volunteered five hours at Faith Mission where she painted buildings and sorted through 75 pounds of donated clothes. Ayoub is pursuing her Community College of the Air Force degree in maintenance production management.

SNCO



Senior Master Sgt. Chirron Hayslett, 445th Aeromedical Staging Squadron superintendent, is the 445th Airlift Wing Senior NCO of the Quarter. Hayslett tackled the wing's self-aid and buddy care program, identifying discrepancies and delinquent members and thus developed immediate training course of action, increasing statistics 97 percent in less than four months. She managed the unit's deployment process where she identified and fixed medical, uniform, pay and waiver issues plus stood up an in-unit processing line for 22 deployers with zero discrepancies. Hayslett managed the final stages of a \$2.5 million building reconstruction, mitigating space and communication issues. The senior NCO provided vital input for an organization chart restructure, increasing members with programs and roles 25 to 90 percent. Hayslett is an active volunteer with the Humane Society, providing 16 hours a month for administrative and tech assistance along with community outreach to help increase adoptions.

CGO



Capt. Michael Harrison, 87th Aerial Port Squadron operations flight commander, is the 445th Airlift Wing Company Grade Officer of the Quarter. Harrison organized the 87th APS Port Dawg Challenge where he designed a 10-phase training event that his Airmen accomplished 1,500 tasks. He led a 12-passenger team to Dover Air Force, Delaware: the group oversaw the movement of 1,389 tons of cargo, 257 passengers and 58 missions. He was integrated with the 60th Air Mobility Wing to support Hurricane Irma missions by moving 1.7 million pounds of cargo and 340 passengers. He revamped the 445th Mission Support Group's awards process. The captain is active in the monthly Wright-Patterson Air Force Base Reserve lunch, fostering the culture of teamwork, camaraderie and mission improvement. Harrison completed the Defense Acquisition University level III life cycle logistics certificate, making him a subject matter expert in the acquisition logistics process.

Godsey managed six buildings, 11 personnel with 24 hours operations; overseeing 40 Morale, Wel-

fare and Recreation events and programs of a 30-day period. This generated \$3,000 in NAF profits and increased



base morale. She was the wing's "RockFest" recreation lead, directing 55 Airmen with an \$8,000 budget. For this event, she coordinated 20 events and gave out \$1,000 in prizes to more than 1,500 participants.

Godsey oversaw two wing renovation projects worth \$66,000, which included modernizing a 10-year-old, \$1 million building involving four teams.
